- 1. <u>ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENT</u> (1 YEAR TENURE UNDER CONSOLIDATED REMUNERATION)

Upper age limits will be 45* years as on date of interview.

- (i) MBBS and MD/MS/DNB Degree from MCI/NMC recognized Medical College / Institution.
- (ii) Qualification and Experience as per "Teachers Eligibility Qualifications in Medical Institutions, 2022" as amended and applicable as on date to the respective posts.
- (iii) Should have registered with MCI/NMC or State Medical Council.

*Relaxation for SC/ST/OBC/PH/Ex-SM candidates will be applicable as per Government Rules.

Emoluments for The Post of Senior Resident (1 year tenure under consolidated remuneration)

For Senior Resident (1 year tenure under consolidated remuneration) - Rs. 1,42,576/- (Consolidated remuneration) per month. In addition to the pay above, the Senior Resident will be entitled for transport allowance with DA on transport allowance as per rules. DA on transport allowance will be revised from time to time as per rules.

The consolidated remuneration will be revised whenever there is revision of rates of DA as per ESIC Hqrs. Office Memorandum no. Z-17/11/1/2007/Med.IV (Pt.file) dated 13.04.2022.

General Terms & Conditions for Senior Resident (1 year tenure under consolidated remuneration)

- a) The appointment / engagement will be for a period of **one year** or till regular incumbent joins, whichever is earlier under consolidated remuneration.
- b) The Senior Resident (1 year tenure under consolidated remuneration) is entitled for leave as per the Contractual Labour [Regulation & Abolition Act] 1970.
- c) Private practice of any kind will not be allowed.
- d) Rules for Reservation will be implemented as per Govt. of India instructions.
- e) The Appointment shall not confer any right or preference for regular appointment.
- f) No claim for any service benefits like PF, Pension, Gratuity, Medical allowances, Medical benefits, Seniority, Promotion etc. will be admissible.
- g) Candidate must be registered with State Medical Council/Medical Council of India/ NMC as applicable, before joining the post.
- h) Candidate in the Government Service should submit "No Objection Certificate" from the employer at the time of Interview and Relieving order at the time of joining.
- i) No TA/DA will be admissible for interview or joining.
- j) ESI Corporation may increase or decrease or cancel filling up of any or all posts without assigning any reason at the discretion of the Appointing Authority.

- k) Candidates applying in OBC/SC/ST/EWS/PWD Category must possess the certificate issued by competent authority, valid for admission/ job in Central Govt. Institutions issued before the date of interview, failing which <u>he/she shall not be allowed to appear in interview for the reserved category.</u> However, he/she can be treated as UR Candidate.

- m) The candidates engaged under PWD quota will be adjusted against the vacancy of respective categories of SC/ST/OBC and UR quota. The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Government Hospitals/Institutions.
- n) The DEAN has the discretion to increase/decrease the number of vacancies depending on actual requirement or to cancel this recruitment or to withdraw offer of appointment.
- o) The Senior Resident (1 year tenure under consolidated remuneration) so selected will be required to submit acceptance/consent letter in writing before appearing for medical examination.
- p) The doctors at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice or payment in lieu of the notice period.
- q) The absence from work for a period of fifteen days without proper permission of the competent authority will amount to voluntary abandonment of engagement and automatic termination. The Senior Resident are required to mark attendance manually as well as in AEBAS (Aadhar Enabled Bio Metric Attendance System) daily during scheduled working days.
- r) They will also be required to attend emergency, floor duty and other clinical duty as assigned by the Competent Authority or his/her subordinate authority authorized.
- s) They will also be required to perform their duties in other departments as assigned by the competent authority.
- t) Selected candidates will have to join duty immediately or the date indicated in the offer of appointment/engagement likely to be issued.
