## SPECIAL TERMS AND CONDITIONS APPILCABLE TO SENIOR RESIDENTS (CONTRACTUAL) ON ONE YEAR.

- I. Tenure of Contract will be 01 year from the date of actual joining.
- II. In case regular incumbent joins in, the appointment shall be terminated immediately. The discretion will be solely of Medical Superintendent.
- III. Private practice will be not allowed.
- IV. Available on call 24x7.
- V. She/He will be entitled for the leave @ 2.5 days for each months of work. On pro rata basis in a calendar year.
- VI. The selected Senior Resident must have a professional indemnity policy which should cover the period as desired by ESIC in the bid. The policy is meant professional falling on them as a result of error and omission committed by them while rendering professional services, The minimum sum assured per annum should be Rs.30 lakhs for Anesthesiologists, Cardiac Surgeon, Neuro Surgeons, Plastic surgeons etc. (2) Rs. 20 lakhs for General Surgeons, Gynecologist, Obstetrician etc. (3) for Physicians Dentists, Radiologists, Pathologists etc. It should be at least Rs.10 lakhs. A copy of the insurance & Premium and receipt must be submitted within 7 days from the date of engagement.

- Applicants with 2 recent passport size photograph, one set of attested photocopies of testimonials (including MBBS pass out marks sheets & certificates, 10<sup>th</sup> passing certificate as proof date of birth and SC/ST/OBC/PH Certificate) and other relevant documents including MCI / State registration certificate, may report to the office of Medical Superintendent, ESIC Hospital, Rudrapur, on <u>18/12/2024</u> up to 11:00 AM and <u>EVERY WEDNESDAY</u> thereafter till the fulfillment of all vacancies.
- 2. Candidate seeking reservation benefits for SC/ST/OBC/EWS must ensure that they are entitled to such reservations per eligibility prescribed in the Notice. They should also be in possession of the required certificates in the prescribed format in support of their claim as stipulated in this Notice. OBC candidates should ensure that they are in possession of valid OBC Certificate issued within such issued by the authority mentioned in the format.

- 3. The candidate claiming reservation / age relaxation on grounds of belonging to OBC should submit the community Certificate in the prescribed proforma vide Govt. OBC certificate must be as prescribed vide DoPT, Govt of India OM No. 36012/22/93-Estt.(SCT) dated 15.11.1993 which should certify that the candidate do not belong to anyone of the Creamy Layers.
- 5. Candidates claiming reservation under EWS category should produce their EWS certificate as prescribed vide DoPT, Govt of India OM No. 36039/1/2019-Estt.(Res) dated 31.01.2019.
- 6. Candidate suffering from 40% or more of the relevant disability shall only be eligible for the reservation for PH category. Certificate of disability in original from any Govt. hospital should be submitted at the time of interview.
- 7. The selected candidate will have to furnish a DD for an amount of Rs. 10,000/-(Rupees Ten Thousand Only) drawn in favour of 'ESIC fund A/c No 1' payable at ESIC Hospital Rudrapur, towards security deposit.
