
- 1) Date of Birth/Matriculation or equivalent certificate in support of proof of Date of Birth.
- 2) Certificates/Mark Sheets etc. in support of Essential Educational/Technical/Professional Qualification for the post.
- 3) Registration Certificate with concerned council, wherever required.
- 4) Experience Certificate, wherever required.
- 5) Category Certificate issued by Competent Authority in the prescribed proforma in respect of candidates belonging to SC, ST, OBC, EWS, Ex-Servicemen.
- 6) Disability Certificate, if applied under the PWBD category.
- 7) Certificate from the Competent Authority in a case where age relaxation has been sought for a basis other than caste/PWBD.
- 8) Candidates seeking reservation benefits available for SC/ST/OBC/EWS/PWD/Ex-Servicemen must ensure that they are entitled to such reservation as per eligibility prescribed in the detailed advertisement and as per the instructions issued by Govt. of India. - 11) Candidates claiming relaxation/reservation under Ex-servicemen Category should submit form of undertaking as given at Annexure -"D".
- 12) ESIC Employees/Central Government/PSU/Autonomous/State Government Employees shall have to produce No Objection Certificate (NOC) at the time of verification along with relieving order before joining the post.
- 13) Two passport size photographs.
- 14) Copy of downloaded registration slip of the online application form.
- 15) Copy of Admit Card/call letter/mail for document verification.
- 16) Photo bearing Identification Proof (self-attested photocopy along with Original) viz, Aadhar card/PAN card/Voter ID Card/Passport issued by the Government.
- 17) Affidavit required in case of mismatch of the Name/Father's name/Surname etc., on various documents.

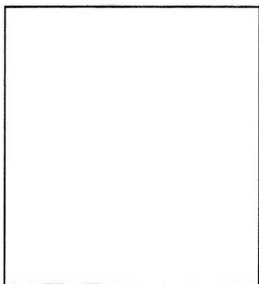
